Terms & Conditions:

1. Interested and eligible candidates possessing the essential qualification and experience can appear for walk-in-interview (as applicable) on the scheduled date along with the duly filled in, prescribed application form (attached).
2. Incomplete applications, application not submitted in prescribed format and application without supportive documents asked for, shall be summarily rejected. Qualification and experience should be in relevant discipline/field and from a reputed institution/organization recognized by relevant authority.
3. Separate applications should be submitted for each post, if applying for more than one post.
4. Experience shall be counted from the date of completion of minimum essential educational qualification. Submission of incorrect or false information during the process of walk-in interview shall disqualify the candidature at any stage.
5. The GSBB reserves right to fill up or not to fill up the post advertised.
6. Candidate should write the Name of Project on the top of the application.
7. No benefit of provident fund, Bonus, Gratuity & Leave Travel Concession, etc. will be considered, since the post is purely on temporary basis.

8. Benefit of increment is eligible for the said posts, subject to the renewal of the services of post as per Office Memorandum of the State Govt. & subject to performance review. The increment will be done as per project policy for the particular post.
9. Age relaxation is admissible to SC/ST/OBC/Departmental candidates including for projects as per Govt. of Goa norms. No age relaxation will be considered for unreserved post.
