I.COMPANY PROFILE

Hindustan Petroleum Corporation Limited (HPCL) is a schedule 'A' Maharatna Central Public Sector Enterprise (CPSE) under the administrative control of Ministry of Petroleum and Natural Gas. HPCL came into being in 1974, by virtue of 'Lube India Limited' and ESSO Standard Refining Company of India Limited Amalgamation Order, 1974, Caltex Oil Refining (India) Limited was taken over by Government of India in 1976 and subsequently merged with HPCL in 1978. The main objective of the company is to undertake Refining and Marketing of Petroleum products and provide energy solutions within India & abroad.

The company employed 8154 regular employees (Executives 5768, Non-executives 2386) as on 31.03.2024.

The authorized and paid up capital of the Company was Rs. 2500 crores and Rs.1418.55 crores respectively as on 31.03.2024.

Its Registered and Corporate offices are at Mumbai, Maharashtra.

ONGC Limited holds 54.90% shares in HPCL as 31.03.2024.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Chairman & Managing Director is the Chief Executive of the Corporation and accountable to its Board of Directors and Government. He/She is responsible for the efficient functioning of the Corporation, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY

Applicants should possess cumulative experience/ exposure for at least 5 years during the last 10 years in Business Leadership/ Finance/ Marketing/ Operations/ Project/ Production Management/ Strategic Consulting in a large organization of repute.
