- 2. Applicants are required to submit the application online using the institute website link https://iiitk.ac.in. Hard copy of the applications will not be accepted.
- 3. Before applying for the post, candidates are advised to satisfy themselves about their eligibility. It is the responsibility of the applicant to assess his/her own eligibility to the post(s) for which he/she is applying in accordance with the advertisement. Level-II: Subject knowledge will be tested in this level. The Examination consists of objective type questions. Maximum duration of exam is 2 hours

Level-III: It is Skill Test/Practical Test/Trade Test with maximum duration of 2 hours.

- a) The Level-I is for Screening purpose only, does not have any weightage in preparation of final merit list
- b) The performance in Level-II and Level-III are considered with equal weightage in preparing final merit list.
