The Bureau is facing staff crunch in accounting sphere at senior ranks viz. Additional Deputy Director/Exe (pay level 13), Joint Deputy Director/Exe (pay level 12), Assistant Director/Exe (pay level 11) and Sr. AO (pay level 11).
